I refer to your letter dated 26<sup>th</sup> January 2015 which, in accordance with section 37F(1) of the Planning and Development Act, 2000, requested further information in relation to the effects on the environment of the proposed Redevelopment of Existing Port Facilities at Ringaskiddy.

In response to the Board's request, I am pleased to enclose:

- Further Information by way of revision to the original EIS. The revised information is presented by reference to specific Sections of the individual Chapters. As explained in blue text in each Chapter, these are the only changes to the text of the original EIS;
- Further Information in the form of a revised Screening for Appropriate Assessment by reference to the issues raised in the request. In this Screening for Appropriate Assessment, revised text is shown in blue. On the basis of its conclusions, a Stage 2 appropriate assessment is not required;

In preparing the enclosed documents, we have reviewed the Schedule of Environmental Commitments presented to the oral hearing. As can be seen from the enclosed documents, the additional information does not change this Mitigation Schedule submitted to the oral hearing.

As appears from the enclosed documents, it is our opinion that this Further Information does not identify any other significant effects or impacts, nor does it contain significant additional information on the effects of the proposed development on the environment, having regard to the material already submitted in the original EIS, the original NIS and as supplemented by evidence to the oral hearing.
